OPEN JUNIOR SHOWMANSHIP SHOW:

This show is open to all juniors age 19 years or less on May 30, 2009 – They are not required to be members of ABGA.

TWO OPEN BOER GOAT SHOWS!!

Competition is open to all goats registered with the ABGA, IBGA, USBGA, or CBGA.

Rules, Regulations, and Judges of the ABGA shall be applied and followed for this show.

ENTRY FEE: \$15.00 per head (1st bedding included)

PEN FEE: \$5.00 each ~ Assignment of pens based on number of entries and tack pens available as space permits. Min. two goats per pen. (large bucks excluded).

EARLY ENTRY DEADLINE: May 15, 2009

LATE ENTRY DEADLINE: May 16, through May 29, 2009 – Late Entry Fee \$20.00 per head

OPEN SHOWMANSHIP CLASS: The participant may use any goat of their choosing for this class. If the goat is not entered in another class, a \$7.00 entry fee will be charged for the Showmanship Class.

ALL GOATS MUST HAVE CURRENT HEALTH CERTIFICATES:

CHECK – IN: Friday May 29, 2009 from noon until 8:00 pm. All animals must be in the barn by 8pm on Friday May 29, 2009. Options for Early Saturday check in available. Contact Gaylene.

**ENTRIES & FEES:** THE SHOW IS OPEN TO ALL EXHIBITORS. THERE IS NO LIMIT ON THE NUMBER OF ANIMALS THAT CAN BE ENTERED IN A CLASS. ENTRY FEE'S ARE AS FOLLOWS:

**ENTRY FEE:** \$15.00 PER HEAD (1ST BEDDING INCLUDED)

**PEN FEE:** \$5.00 EACH ~~ ASSIGNMENT OF PENS BASED ON NUMBER OF ENTRIES AND TACK PENS AVAILABLE AS SPACE PERMITS. FEE FOR TACK PENS WILL BE \$5.00 EACH.

**EARLY ENTRY DEADLINE:** MAY 15, 2009

**LATE ENTRY DEADLINE:** MAY 16, THROUGH MAY 29, 2009 – LATE ENTRY FEE \$20.00 PER HEAD

**OPEN JR. SHOWMANSHIP CLASS:** THE PARTICIPANT MAY USE ANY GOAT OF THEIR CHOOSING FOR THIS CLASS. IF THE GOAT IS NOT ENTERED IN ANOTHER CLASS, A \$7.00 ENTRY FEE WILL BE CHARGED FOR THE SHOWMANSHIP CLASS. PARTICIPANTS ARE NOT REQUIRED TO BE MEMBERS OF THE JRABGA

CHECKS SHOULD BE MADE PAYABLE TO SOUTHERN GOAT PRODUCERS ASSN., INC. AND REMITTED WITH ENTRY FORM.

**ELIGIBILITY OF ANIMALS:** ALL GOATS MUST BE REGISTERED IN THE HERD-BOOK OF A RECOGNIZED ASSOCIATION BEFORE MAY 15, 2009. RECOGNIZED ASSOCIATIONS INCLUDE ABGA, IBGA, USBGA AND THE CANADIAN BOER GOAT ASSOCIATION. ORIGINAL REGISTRATION CERTIFICATES ARE REQUIRED AT CHECK-IN. KIDS LESS THAN 3 MONTHS OF AGE MAY BE ACCEPTED WITH A REGISTRATION APPLICATION STAMPED WITH THE DATE RECEIVED BY ONE OF THE LISTED ASSOCIATIONS.

**OWNERSHIP:** OWNERSHIP SHALL BE THE NAME(S) OF THE PERSON(S) LISTED ON THE REGISTRATION DOCUMENT. PERSONS SHOWING ANIMALS WHOSE REGISTRATION CERTIFICATE HAVE SIGNED TRANSFER THAT HAS NOT BEEN PROCESSED BY THE ABGA, IBGA, CBGA OR THE USBGA OFFICES MUST SHOW THESE ANIMALS AS AGENT FOR OWNER ON RECORD. AN EXHIBITOR SHALL NOT PRESENT AN ANIMAL TO BE SHOWN UNDER A JUDGE FROM WHOM IT WAS PURCHASED OR POSSESSION TAKEN LESS THAN 90 DAYS PRIOR TO THE DATE OF THE SHOW.

**IDENTIFICATION & TATTOOS:** ALL GOATS MUST BE APPROPRIATELY IDENTIFIED AND COMPLY WITH USDA SCRAPIE ERADICATION PROGRAM GUIDELINES. CALL 1-800-USDA-TAG OR VISIT THE FOLLOWING WEBSITE FOR MORE INFORMATION: [HTTP://APHIS.USDA.GOV/ANIMALHEALTH/ANIMALDISEASES/SCRAPIE/](http://aphis.usda.gov/animalhealth/animaldiseases/scrapie/) ALL GOATS MUST HAVE LEGIBLE TATTOOS OR OTHER MEANS OF PERMANENT IDENTIFICATION CONSISTENT WITH ITS REGISTRATION CERTIFICATE OR THE ANIMAL WILL BE DISQUALIFIED. POINT WINNERS FROM EACH CLASS MUST HAVE THEIR TATTOOS READ AND RECORDED. IF THE ANIMAL HAS A MICROCHIP AS ITS PERMANENT IDENTIFICATION, THE EXHIBITOR IS RESPONSIBLE FOR PROVIDING A MICROCHIP READER.

**ENNOBLED HERD BOOK POINTS:** ONLY GOATS ENTERED UNDER THEIR ABGA REGISTRATION NUMBER AND PRESENTING THEIR ABGA CERTIFICATE OF REGISTRATION WILL BE ELIGIBLE TO EARN POINTS FOR THEIR ACTUAL PLACING IN THE SHOW AS DESCRIBED IN THE ABGA "CRITERIA FOR ENNOBLEMENT OF A BOER GOAT".

**LIABILITY:** ALTHOUGH EVERY PRECAUTION WILL BE TAKEN TO PROTECT THE SAFETY AND COMFORT OF THE EXHIBITORS, NEITHER THE SHOW SPONSORS, SHOW MANAGEMENT NOR T. ED GARRISON ASSUMES ANY RESPONSIBILITY IN THIS MATTER AND DISCLAIMS ANY LIABILITY, LEGAL, OR OTHERWISE, IN CASE OF ACCIDENTS, INJURY, OR LOSS OF PROPERTY. EXHIBITORS ARE LIABLE FOR ANY DAMAGE HIS/HER GOAT(S) MAY INCUR. IF ANY GOAT IS DEEMED UNRULY OR A THREAT TO THE PUBLIC, THE ANIMAL WILL BE REMOVED FROM THE SHOW. THE JUDGE'S DECISION IS FINAL.

**COMPUTING AGES:** BIRTH DATES, AS LISTED ON THE REGISTRATION CERTIFICATE WILL BE USED TO DETERMINE THE CLASS DIVISIONS. IN ORDER TO CALCULATE CLASS BREAKS, TAKE THE SHOW DATE AND COUNT BACK TO THE BIRTH DATE TO DETERMINE THE AGE AND THE CLASS FOR THE ANIMAL.

**CLASSES:** ALL ANIMALS MUST BE REGISTERED PUREBRED, FULLBLOOD, OR PERCENTAGE BLOOD BOER GOATS. PERCENTAGE DOE CLASSES ARE FOR GOATS 50% TO 88%. FULLBLOOD/PUREBRED CLASSES ARE FOR DOES THAT ARE 15/16 BLOOD (94%) AND HIGHER. 31/32 BLOOD (97%) AND HIGHER FOR BUCKS. PROGENY OF FRESH DOES WILL NOT BE ALLOWED IN THE RING. AT THE DISCRETION OF THE JUDGE AND THE SUPERINTENDENT, GOATS MAY BE LET LOOSE IN THE RING AS A FUNCTION OF JUDGING. THE CHAMPION AND RESERVE CHAMPION CLASSES WILL BE CHOSEN FROM THE DIVISION CHAMPIONS SELECTED EARLIER IN THE SHOW. MANAGEMENT RESERVES THE RIGHT TO COMBINE OR SPLIT CLASSES. JUDGES DECISION IF FINAL. A COMPLETE DETAILED COPY OF THE SHOW CLASSES IS CONTAINED WITHIN THE CONTENT OF THIS SHOW PACKET.

**DISQUALIFICATION:** ANY GOAT SHOWING ANY PRONOUNCED DEFECT OR ABNORMALITY WILL BE BARRED FROM THE SHOW IN ANY BREEDING CLASSES. ARTIFICIAL COLORING WILL BE A DISQUALIFICATION AS WELL AS ILLEGIBLE TATTOOS OR TATTOOS THAT ARE INCONSISTENT WITH THE GOAT'S REGISTRATION PAPERS. ANY DOE OVER 24 MONTHS OF AGE THAT HAS NOT KIDDED AND CANNOT PROVE CURRENT PREGNANCY WILL NOT BE ALLOWED IN THE SHOW.

**HEALTH:** AN OFFICIAL HEALTH CERTIFICATE SIGNED BY AN ACCREDITED VETERINARIAN ISSUED WITHIN 30 DAYS OF ENTRY MUST ACCOMPANY ALL GOATS. THIS CERTIFICATE MUST INCLUDE:

- NAME AND ADDRESS OF EXHIBITOR.
- DESCRIPTION OF EACH ANIMAL INCLUDING BREED, AGE, SEX, AND ANY REGISTRATION, TATTOO, OR EAR TAG NUMBERS.
- A STATEMENT BY THE VETERINARIAN SIGNING THE HEALTH CERTIFICATE THAT THE GOATS LISTED ARE NOT INFECTED WITH, OR HAVE BEEN RECENTLY EXPOSED TO ANY COMMUNICABLE DISEASE TO THE BEST OF HIS/HER KNOWLEDGE.
